Hudson and Sensis announce strengthening of on-site partnership

Sydney, Australia – 6 July 2007 – Hudson and Sensis are pleased to announce they have successfully renegotiated their On-Site Managed Service agreement for a further 12 months.

In addition to the renegotiation of the current agreement, Hudson has also secured a new On-Site Managed Service solution for a separate line of the Sensis business - the Trading Post Group (TPG).

Hudson will take over the Trading Post Group (TPG) solution from Talent 2 on 23 July 2007.
